

Guidance Notes Application for Community Division

These Guidance Notes are of a general nature and are not intended to, and cannot, replace the advice of a Legal Practitioner or Registered Conveyancer.

GENERAL INFORMATION

Section 223J of the Real Property Act 1886 (RPA) allows the Registrar-General to reconcile boundaries as shown on titles with the boundaries of the land occupied. There are, however, limits on its use. This is because the provisions of Part 19AB of the RPA specifically deal with the re-arrangement of boundaries. Section 223J should, therefore, only be applied when it is inappropriate to use Part 19AB.

Part 19AB has a wide ambit. This means that the scope for section 223J is quite narrow. It should be limited to minor changes to boundaries.

Initial enquires regarding applications under section 223J are to be directed to Plans Client Advice Officer (ph 08 8423 5000). Preliminary approval must be obtained before proceeding with the application.

GENERAL GUIDELINES

An application must be made to the Registrar-General for the amendment of the relevant certificates of title.

The application must be accompanied by, if not already lodged, a fully certified survey plan defining the boundaries to be reconciled.

Any amendment under s 223J is to:

- * Be within a specified distance unless otherwise approved by the Registrar- General
 - metropolitan¹ areas 200 millimetres or less
 - non-metropolitan² in the form of a ratio of >1:500
- * Accommodate substantial occupation that a reasonable person would take to be the boundary of the title
- * Accommodate long standing occupation (minimum of 30 years) unless the circumstances of a particular case warrant a lesser period and
- * Should not involve easements, unless accompanied by an application to vary the easement

APPLICATION

A combined application and declaration is to be made³, to the Registrar-General on Form B2 with a prefix of RT. The application:

- * Will be numbered on lodgement to enable tracking of the application through the Lands Titles Office
- * Certifications in relation to verification of identity, client authorisation, retention of evidence and correct and compliant do not apply.
- * Must be submitted to RevenueSA prior to lodgement. Where consideration has been paid the amount must be reflected in the declaration.
- * Does not require registration or new title fees



¹ 'Metropolitan' is defined as a parcel of land that is situated amongst others of similar size within a closely settled area.

² 'Non-metropolitan' is rural land that does not involve a parcel of land less than 0.50ha in size.

³ Annexures A, B, C, and D are the suggested wording for applications and consents for lodgement with the Lands Titles Office

The combined application and declaration are to be dated and signed by the registered proprietors of the land affected and be witnessed by a person authorised by law to take such declaration. The witness need not include details required by section 267 of the RPA.

Parties who have or claim an estate or interest in the land must consent either within the application, or on an Annexure Form B1 to be attached to the application. The signatures of consenting parties need not be witnessed.

Each application is considered carefully and must satisfy the guidelines as provided above. It is important that the 223J provision is only utilized when it is appropriate and is not an avenue to avoid the planning processes and division under Part 19AB.

PLAN

Either a Filed Plan (F) or a Division Plan (D) can be used for amendments under section 223J, however a Division Plan can only be used when the plan also involves the division of land. The requirements for the applicable plan are set out in the Plan Presentation Guidelines and can be lodged with the appropriate fees.
