A3 - APPLICATION TO REGISTER MARRIAGE

The information contained in these notes is to be read in conjunction with "GENERAL NOTES RELATING TO PANEL FORMS".

NOTES.

Instructional notes contained on the form must be read carefully before attempting to complete the information required in the panels.

HEADING.

The heading will be completed as "APPLICATION TO REGISTER MARRIAGE".

CERTIFICATES OF TITLE AFFECTED.

In this panel insert "The whole of the land comprised in Certificate of Title (or Crown Lease) Register Book Volume Folio".

ESTATE AND INTEREST.

See Note 4 on the form.

If as mortgagee (or Lessee), show - "As mortgagee (or Lessee) under and by virtue of memorandum of Mortgage (or Lease) No."

APPLICANT.

This panel will be used to identify the applicant only. The name of the husband must not be introduced here. Show the full name, address and occupation of the applicant. This will be her correct married name, and her current address and occupation which should be linked with the Register Book as "formerly of" if necessary. After the name, address and occupation add "being registered as" (insert full name as registered).

Many cases arise where the applicant is registered incorrectly on either the Certificate of Title or Certificate of Marriage (or both). She may have changed her name after being registered but prior to the marriage. Possible variations are extensive. See Appendix "A" for some variations and the way this panel can be completed to cover the circumstances.

THE APPLICANT HEREBY APPLIES

Certificate of Marriage or Certificate of Title (or both), or where he is registered jointly with the applicant on the Certificate of Title. See Appendix "B" for some variations and examples of how the husband can be identified.

STATUTORY DECLARATION.

There is NO NEED to provide a Statutory Declaration or certification to identify the registered proprietor with the person named in the Certificate of Marriage. Reliance will be placed on the executing party and on the certifying party that the information supplied is in fact correct. Certified copies of the Marriage Certificate will still need to be attached, and any other such evidence that the Registrar-General may require.

EXECUTION AND PROOF.

Follow note 5 on the form.

Note that the full name of the applicant will not be required in the execution clause or proof. Merely substitute the word "applicant" in lieu of the name in those places.

VARIABLE CIRCUMSTANCES.

After carefully reading these guidance notes and the appendices it is believed that this form will be suitable for all applications to Register Marriage.

The links to the registered proprietor must be clearly narrated and supported by additional evidence where necessary.

AGENTS.

Note that an agent CANNOT now make this application on behalf of the applicant. See amendment No.51 of 1979 to Section 189 of the Real Property Act 1886-1980.
