Title Watch

Title Watch is an online subscription service that monitors activity against a selected certificate of title. When activity is detected, a subscriber will automatically receive an email and an optional SMS alert. Activities that trigger notifications include:

- Purchase of a Property Interest Report or Form 1 product
- Lodgement of a Priority Notice
- Lodgement of a Document
- Cancellation of a Title
