NEW ENQUIRY CURRENT TITLE REFERENCE FROM CANCELLED TITLE

No.93

Early in 1993 a survey was conducted with clients attending the Titles Registry to ascertain the reasons why they were looking at the Register Book. It became very apparent that the main reason was to ascertain new title references from cancelled titles which were not issued as TATS titles.

To avoid the need to continue manual searching a new enquiry has been developed and is available at no charge from all remote user terminals and the self serve terminals on the ground floor of the Colonel Light Centre.

This enquiry is not valid for a TATS title or where the cancelled title has been replaced by a TATS title. In these instances the existing TFONWT enquiry should be utilised.

Using the new Enquiry (FMTCT)

Entry of the cancelled title reference will display either:

- the current title where the plan/parcel has not changed (e.g. full book), see Example A attached.
- a list of parcels and titles where more than one title has issued following cancellation (eg. pursuant to a plan of division), see *Example B* attached.

Current title references cannot be supplied in the following instances:

- where the cancelled title has a land description comprising part parcel(s), or multiple parcel.
- in more complex cancellation situations, since it is not always possible to display the complete transaction.

In each of the above cases an appropriate message will be displayed and will require a manual search.

As a result of the continuing automation of the Register Book, new TATS certificate of title references are no longer being noted on the cancelled original metric and imperial titles, nor on the associated documents. New title references can be ascertained using the TFONWT enquiry while details of the parent title can be obtained through the TFOPAT enquiry.
