**Updated South Australian Operating Requirements and Participation Rules** 

## South Australian Operating Requirements and Participation Rules

Under sections 22, 23 and 25 of the Electronic Conveyancing National Law (SA) Act 2013 (ECNL Act), the Registrar-General has updated Operating Requirements (OR) and Participation Rules (PR) for South Australia to replace version 5 of those documents:

The South Australian OR and PR are based on the Model Operating Requirements (MOR) and Model Participation Rules (MPR), published by the Australian Registrars' National Electronic Conveyancing Council (ARNECC). Version 6 of these regulatory documents will come into effect on 12 April 2021.

Version 6 of the South Australian OR and PR include amendments to definitions and eligibility requirements, as well as:

- enhanced security and testing requirements for both ELNOs and Subscribers
- changes to the good character and reputation requirements
- Verification of Identity updates
- enhanced requirements for integration with ELNO systems
- requirements relating to ELNO's service suppliers (contractors)
- updated Digital Certificate requirements
- new ELNO Implementation Plan requirements
- updated timeframes within which ELNOs must make Registry Instruments and other electronic documents available
- additions to Business Name requirements
- deletion of Subscriber as Attorney provisions
